Focal Transfer Terms of service May 2018

Focal Transfer is the easiest and nicest way for photographers to send photos and files to their clients. We offer a free service ("Focal Transfer Regular") as well as a Premium subscription service ("Focal Transfer Premium"), including additional features and functionalities (together: the "Services").

The Services are provided to you, the user of the Services, by Focal Transfer which is a trading name for KeyAGENT ltd, with its main office at 3 Loughborough Street, London, SE11 5RB, registered Registered in England and Wales under Number 07144564.

1. Applicability

- 1.1 By using the Services you accept these Terms in full and agree that these Terms are reasonable. If you disagree with these Terms in full or in part, or disagree that they are reasonable, then you must not use the Services.
- 1.2 Focal Transfer can amend the Terms of Use from time to time. Focal Transfer recommends that you review the Terms of Service from time to time and take note of any changes. By continuing to use the Services you accept any change made to the Terms of Service.
- 1.3 These Terms of Service supersede any and all prior oral and written quotations, terms, communications, agreements and understandings between you and Focal Transfer.
- 1.4 Clause 2 regards the use of Focal Transfer Regular only. Clauses 3, 4 and 5 regard the use of WeTransfer Plus.

2. Focal Transfer

- 2.1 Focal Transfer is free from registration and charge.
- 2.2 If you use Focal Transfer, we will show you full-page wallpaper ads from advertisers and artists selected by us.
- 2.3 Focal Transfer provides the possibility to transfer digital files and share content up to a maximum total capacity. You can find the current limitations of the Focal Transfer website.
- 2.4 Uploaded files are stored and available to download on Focal Transfer's servers for a limited period of time and will expire automatically after. You will be notified of the expiration date in the

confirmation email sent to you. Each transfer can be sent to a limited number of email addresses per transfer. Each email is sent separately to each individual recipient.

2.5 After the expiry period mentioned in clause 2.4, Focal Transfer will permanently delete the uploaded files. These files will not be available nor retrievable anymore.

3. Confidentiality

- 3.1 Any file transfer between you and recipients is treated confidentially. Focal Transfer does not provide any public search function, catalogue or listing to find transfers that would be available. As a Premium user you can search your own transfers.
- 3.2 Focal Transfer will not look into your transfer or files, unless this is necessary and in line with our Privacy & Cookie Statement, for instance to provide you with (technical) support on your request or if we are by law obliged to do so.
- 3.3 You acknowledge that download links can be forwarded and whoever is passed on or has access to a download link can download the files contained in that transfer. Focal Transfer Plus offers the option to protect transfers with a password, which is only stored encrypted and not accessible for anyone. It's the responsibility of the uploader to share said password.

4. Ownership and operation

- 4.1 Focal Transfer does not claim any ownership of the contents of the files you transfer through our Services. You are fully and solely responsible and accountable for the files you transfer through our Services.
- 4.2 By using our Services you guarantee that you have, for each file (including wallpapers), all required permissions, including from copyright and other intellectual property rights holders, to distribute, transfer, store and/or make available online as part of our Services.
- 4.3 Focal Transfer is not liable to you or any third party for any damages arising out of the content shared by you and the use, reuse, or adaptation of background wallpapers chosen independently by you, including but not limited to, copyright protected works and/or trademarks.

All intellectual property rights and/or similar rights to the (content and design of the) Focal Transfer website, including the software, wallpapers, photography, graphic design, typography, portraits and logos, as well as trademarks, copyrights and trade names featured on wallpapers used within the Services, are vested in Focal Transfer or its licensors.

5.2

A large number of the wallpapers, including photography, graphic design, typography, portraits and logos, as well as trademarks and tradenames featured on wallpapers used within the Services, are the intellectual property of their respective rights holder.

5.3

You are not allowed to copy, reproduce, make available online to the public, sell or reuse anything from the Focal Transfer website, including the wallpapers in any way without the permission of the rights holder. Focal Transfer is not responsible or liable for the contents of wallpapers, in-ad links to external websites or the contents, products or services offered on external websites. You accept that all use outside the Focal Transfer website is at your own risk.

6 Restrictions

6.1 Focal Transfer respects your rights and expects that you respect those of Focal Transfer, its artists, advertisers and third parties. This includes respecting the right to privacy, corporate intelligence and business secrets and intellectual property rights, such as trademarks, copyrights, trade names and logos. You agree not to use the Services to commit or promote, enable or facilitate unlawful or criminal acts or violations of these Terms of Service or facilitate or promote others to do so.

6.2

As a condition to make use of the Services you agree not to transfer, distribute or store any files or use any wallpapers that:

- feature child pornography;
- are obscene, defamatory, libellous, slanderous, profane, indecent or unlawful,
- promote racism, violence or hatred;
- are factually inaccurate, false, misleading or deceptive;
- you don't have the right to copy and/or transfer;

- infringe, violate or misappropriate intellectual property rights, privacy rights, including data protection rights, and/or any other kind of rights;
- infringe on or violate any applicable law or regulation;
- constitute 'hate speech', whether directed at an individual or a group, and whether based upon the race, sex, creed, national origin, religious affiliation, sexual orientation or language of such individual or group, and/or;
- facilitate or promote gambling, or the sale or use of liquor, tobacco products or illicit drugs.

In addition, you agree not to:

7.1

When a wallpaper or personal Premium profile is used in violation of these Terms of Service and/or any applicable law or regulation, Focal Transfer reserves the right to investigate and/or remove, without warning, any wallpapers you display on your Focal Transfer Premium account or

Focal Transfer Premium personal profile channel, or block anyone from accessing your Focal Transfer Premium account or Focal Transfer Premium personal profile.

8 Availability of Services and warranties

8.1

Focal Transfer cannot promise that the Services will be available uninterrupted, secure or on an error free basis. If an error occurs with the App, you should report it to info@Focal Transfer.com and Focal Transfer will attempt to correct the error. Your access to the Services may be occasionally restricted to allow for repairs, maintenance or the introduction of new facilities, services or content. Focal Transfer will attempt to restore access as soon as is reasonably possible. 8.2

The Services are provided without any representations or warranties, express or implied and Focal Transfer makes no representations or warranties in relation to the Services or the information and materials provided in the Services. Focal Transfer does not warrant that the information on the website is complete, true, accurate or non-misleading; or that the Services will be constantly available or available at all.

9 Indemnity and liability

9.1

You will defend, indemnify and hold harmless Focal Transfer, including its employees and affiliates, from and against any claims, incidents, liabilities, procedures, damages, losses and expenses, including reasonable legal and accounting fees, arising out of or in any way connected with your access to or use of the Services or your violation of these Terms of Service, including any third party claims that files submitted to the Services by you or through your account infringe or violate any third party rights.

Focal Transfer is not liable for any damage or personal injury resulting from any use of the Focal Transfer website or Services. The limitation of liability referred to in this clause shall not apply if the liability for damage is caused by intent or gross negligence on the part of Focal Transfer. 11 Log Data

11.1

11.2

12.1

Personal Information that Focal Transfer collects may be stored and processed in and transferred internationally to enable the use of the information in accordance with this Privacy Policy. By using the Services you agree to such cross-border transfers of Personal Information.

13 Cookies

13.1 Cookies are files with small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your computer's hard drive.

13.2

Like many sites, this website uses Cookies to collect information. You can instruct your browser to refuse all Cookies or to indicate when a Cookie is being sent. However, if you do not accept Cookies, you may not be able to use some portions or services of the website.

14 General

14.1

These Terms will be subject to the laws of England and Wales and the courts of England and Wales are the only place where disputes or claims relating to or connected with these Terms may be decided.
